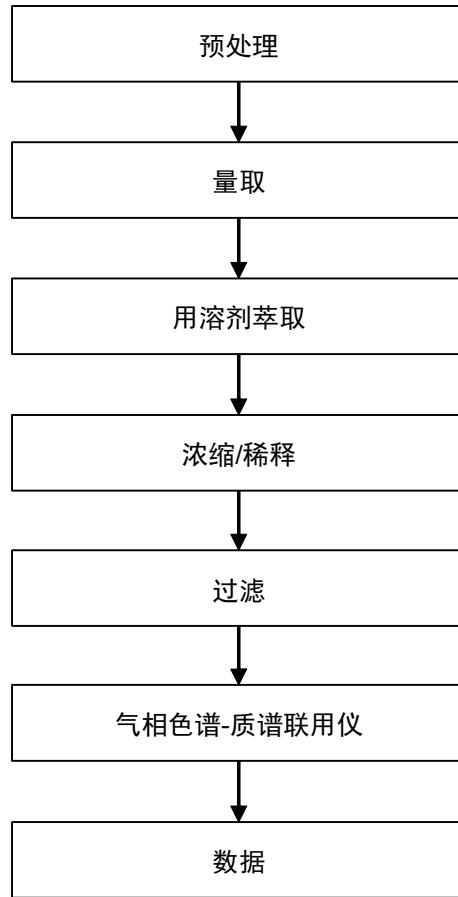

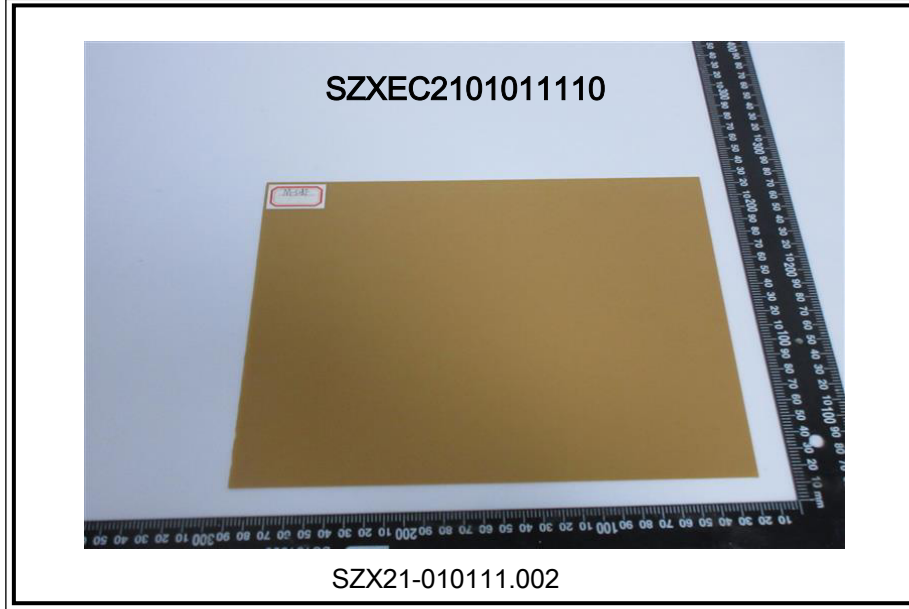
### Phthalates 测试流程图
